Required Materials

Financial Calculator: The recommended calculator for this course is the **HP 10B II**. Any calculator that is capable of performing time value of money, amortization, net present value and internal rate of return calculations will be sufficient. However, the notes for this class are designed for the **HP 10B II** and financial calculations will be taught with this calculator only. You are responsible for learning the keystrokes of any other calculator.

Computer resources and internet access: This is a web based class. You must have reliable high speed access to the internet and a reliable computer to take this class. Saying that you are having problems with your computer is not a valid excuse for not completing assignments.

Browser: You must use **MOZILLA FIREFOX** Browser to take the Quizzes and Exams or you will have problems. If you have technical problems as a result of using another browser, then I will not adjust your score or reset you assignments. Mozilla Firefox is available at http://www.mozilla.com/en-US/firefox

Electronic Resource:

Blackboard will be used for this course. The sign-on site for Blackboard is http://blackboard.uncg.edu. Students enrolled in this course will have access to the applicable section of Blackboard. All course materials, exams, quizzes and assignments will be done through Blackboard.

Check your UNCG email **DAILY** for email messages from me and check the Blackboard Announcements regularly. I will post announcements and other information on BB. Use my email address at the top of page one of this syllabus when sending me messages. Failing to read the syllabus, emails or BB announcements/updates will not constitute an excuse for missed work, assignments or tests.

Course Objectives:

FIN 315 is a common body of knowledge course for students pursuing a degree in business or economics. Upon the completion of the course students should be able to do the following:

- 1. Discuss the interrelated areas of finance, the role of finance within an organization, forms of the business organization, agency problems, and the factors that influence the stock price.
- 2. Explain the information provided by the income statement, balance sheet, statement of cash flows and how modifications of accounting data can be used for making corporate and stock valuation decisions.
- 3. Describe the nature of ratio analysis, the groups and types of ratios, the DuPont system, and quantitative and non-quantitative factors in evaluating a company's performance.
- 4. Identify the steps in the financial planning process.
- 5. Describe the different financial markets, financial market instruments, the components and factors influencing the interest rate, the yield curve, and explanations for the shape of the yield curve.
- 6. Define risk, return, diversifiable risk, market risk, and explain how to measure and apply required risk and return in the context of an individual stock and a stock portfolio.
- 7. Demonstrate how to find the present and future values of lump sums and annuities, solve for the time or interest rate in TVM problems, calculate periodic and effective interest rates, and construct a loan amortization schedule.
- 8. List the main classifications and characteristics of bond, calculate bond price and various bond yields, and explain the importance of bond ratings and criteria for rating bonds.
- 9. Identify important stock ownership rights and terms, how to value common and preferred stock, and understand stock market information in the newspaper and market efficiency.
- 10. Explain the concept of a firm's weighted average cost of capital, define and calculate the component costs of capital using alternative approaches, calculate the weighted average cost of capital, and identify situations when the use of the composite WACC is not appropriate.
- 11. Explain capital budgeting and steps in the capital budgeting project, methods to evaluate project financial viability, NPV profiles, the problem of multiple IRRs.

Class Organization, Procedures and Expectations

Online Learning: This is an online class where all of your learning will be done through use of the textbook and materials available online. The best way to learn the material is by reading the assigned chapters in the text, reading the notes the go with each chapter, watching the videos located on the Course Learning Area for each section, completing the required problems from the text for each chapter, working and reworking the sample questions and problems provided in Blackboard. Your final grade will be based upon your performance on the Chapter quizzes and the Exams. There are no opportunities for extra credit in this class.

Online learning **does not** mean that you can work at your own pace or on your own schedule. There is a detailed schedule at the end of this syllabus of the material to be covered and when it will be covered. The online quizzes and exams have scheduled exam windows when you must complete them. It is your responsibility to look at this schedule and adjust your schedule to be able to take them during the scheduled windows.

To do well, it is a subject that most students must study regularly instead of waiting until the last minute to cram. You should:

- 1. Read and STUDY the assigned materials for each assigned date in order to keep up.
- 2. PAY ATTENTION TO DATES AND TIMES FOR THE QUIZZES AND THE EXAMS! You may not make up the quizzes and only with prior approval will I allow you to make up a missed exam.
- 3. Do NOT get behind! Do this on a regular basis.
- 4. PAY CAREFUL ATTENTION TO CHAPTERS ASSIGNED WE DO NOT GO IN ORDER OF THE TEXTBOOK!!
- 5. Check email and BB Announcements frequently so you don't miss important information.

If your work schedule, travel schedule or other responsibilities will not allow you to complete the required assignments at these times, then you need to drop this class. Exam and Quiz Guidelines

- 1. The exams and quizzes will only be available for the 16-hour period noted. If it is not taken in that time period, you will **receive a zero**. (see make-up exam policy below)

- 5. The exams and quizzes will be multiple choice. You will need to identify and understand keywords and concepts, and also be able to solve problems. The end-of-chapter questions and problems and sample multiple choice questions will be very helpful for doing well on the multiple choice questions on the exams. The quizzes and exams will present you with one question at a time. You must answer the question before moving to the next question. There is no backtracking allowed on the quizzes and exams Blackboard will prevent it.
- 6. If you experience any technical difficulty during the exam, then contact me immediately by email describing the issue and I will do my best to have it fixed. If you are kicked out of Blackboard for some reason (i.e. You hit the wrong button, your browser crashes, etc.) then you can log back into blackboard and start where you left off. Please be aware of the weather forecast and try to complete you assignments before any weather activity that could disrupt your access to the exam.

<u>There are no makeup exams</u>. You must take the quizzes and exams within the designated window unless you have an approved excuse. There are no make ups for the quizzes or exams. For an

excused exam, the weight attributable to a missed exam will be allocated to the final exam. Please try to notify me at least 48 hours <u>prior to</u> the exam. 1. Course Documents:

Syllabus – You must read and understand the syllabus.

Course Notes – This folder contains notes to accompany each chapter in the text book. The notes are also provided in the course learning area (see below) with the related videos. There are some minor differences and the notes sometime provides different examples and do not include the video examples. You should first read the notes in the course learning area and watch the videos. I have provided PDF versions of the notes here because some students prefer to print them out and review them prior to the exam and the course learning area does not easily lend itself to printing.

Audio Lectures – This folder has recordings of my classroom lectures taught face-to-face. If you need additional instruction beyond the Learning Area and Course Note, you may find these audio lectures helpful. They are listed by date rather than subject, however, you should be able to find the appropriate chapter after some searching. Also included is a lecture outline and Martin Mfg. Company handout to accompany the audio instruction. The recordings are for your personal study only. You are not permitted to share them with anyone outside the class or use them for any other purpose. You may have difficulty loading it in Blackboard, so I would suggest saving it on your computer by right clicking on the file and choosing "Save Link As." Windows Media Player should play the file.

PowerPoint Slides – This folder contains the PowerPoint Slides provided by the publisher.

Instructor's Manual – This contains the instructor's manual that accompanies the text book. The solutions to the end of the chapter problems are included. You are to practice by working the sample problems listed below for each chapter and check your answers using the instructor's manual.

Supplemental Problems with Video Solutions – This folder contains practice problems, final solutions to the problems, and video solutions showing the detailed steps to solving the problems. You should practice these problems AFTER you do the Gitman textbook problems but BEFORE the supplemental review problems for exams.

Supplemental Review Problems for Exams – This folder contains multiple choice problems and their solutions. These are practice problems from old exams. Do these AFTER you have studied

the textbook, done the end-of-chapter textbook problems also have completed the Supplemental Problems with Video Solutions.

Supplemental Review Conceptual Questions for Exams – These are multiple choice questions that focus on conceptual type questions. In some chapters, I have also included some math problems. The conceptual questions are important to study because they are a good indication of the type of non-math questions you can expect.

Other Sample Exams – This folder contains old sample exams. The exams should be somewhat easier than the supplemental review multiple choice conceptual questions and problems posted.

More Sample Exams and Practice Problems – This folder contains additional practice exams and problems.

Time Value of Money Tutorials – This folder has various tutorials for learning time value of money, which is Chapter 5 of the Gitman textbook. Use these resources to learn TVM, and also, to learn how to use your financial calculator. Read Gitman Chapter 5 BEFORE going through the videos and exercises. Then, practice the end-of-chapter textbook problems, the supplemental review problems with video solutions, and the supplemental review problems for exams.

2. Course Learning Area

The Course Learning Area provides notes, videos and narrated slides for this course through Wordpress. The course is contained here and other than reading the text this is where you should spend most of your time. You may be familiar with using Wordpress through other classes. You should read the notes and listen to the videos and narrated slide for each chapter in addition to reading the text. The text provides more detailed information in some cases, provides more definitions and introductions to key concepts that you should know but that are not repeated in the notes so both are important

- **3. External Links** This section provides links to external sties that can help you with using the financial calculator. It also provides a link to the Textbook website where there are some additional sample problems. Included is a link to the publisher's website. The publisher's website contains a self assessment quiz for each section that will help in preparing the material for the course.
- **4. Assignments** This is where all of the quizzes and exams for the course will appear.
